4. After taking the affiliation from CBSE New Delhi, school management will be committed to pay the salary and other allowances etc. through Account



Payee cheques to teaching staff and Non-teaching staff like government employee. If failing which then in this case No objection Certificate will be taken back immediately.

5. You self and your management will ensure that if any information demanded by any senior authority of any Education Department or Education officer of your District then the necessary information will be provided to him and also given the necessary support. If failing which then in this case No objection Certificate will be taken back immediately.
6. Security of children, Public Health Sanitation and regarding the terms and conditions of issuance of other No objection certificates, will be inspected time to time by the authorities of Government. In any negligence has been found in any condition then at the time of issuance of No Objection Certificate then No Objection Certificate will be taken back.
